A General Meeting of the Society will be held at 7.30 p.m. on Wednesday 13th July at Carlyle School, Hortensia Rd., S.W.3. Im response to my request to you, various members have sent letters. As a result, two Committee meetings were held to enable some amendments to be made to the original draft. A motion at the General Meeting will be that the existing Constitution be replaced by the original draft with these amendments. Under the existing Constitution motions must be received, duly signed and seconded, not less than three days before the Meeting. Motions to amend the Constitution and other motions will not therefore be accepted from the floor.



SOCIETY FOR INTERNATIONAL FOLK DANCING

Constitution June 1949

1. The Society shall be called the Society for International Folk Dancing and its objects shall be:

(a) To promote, encourage and teach Folk Dancing of all races.
(b) To collect and record details of such dances
(c) To further international friendship and understanding in this way.
(d) To do anything to further the above objects.

- 2. The Society is non-sectarian and non-political and no political use is to be made of the Society at any time.
- 3. Membership shall be open to any person subject to the committee's discretion. The committee shall have power to refuse an applivation for membership or to expel a member, subject to the ratification of the next ensuing General Meeting of members.
- The management of the Society shall be in the hands of a committee which shall consist of a Chairman, Secretary, Treasurer and six other members, all to be elected annually. An auditor, who shall not be a member of the committee shall be elected at the same time. Any vacancy on the committee may be filled by co-option, the vacancy to be filled by election at the next General Meeting of the Society. If a member of the Committee is absent from three consecutive committee or general meetings, without a reasonable excuse, his appointment shall be : rendered vacant.
- 5. The committee shall have power to appoint sub-committees for such purposes as from time to time they may consider necessary or expedient. All decisions of these committees are subject to ratification by a two-third majority of the committee.
- 6. An Annual General Meeting of the Members shall be held as soon after 15th September as may be convenient in each year. At least one other General Meeting shall be held during the year. A General Meeting shall be called within one month of the receipt by the Secretary of a request for such a meeting signed by not less than one tenth of the membership. At least 10 days' notice of the holding of a General Meeting shall be given to all members. Any motion that is proposed and seconded shall be placed upon the Agenda provided that it is received by the Secretary at least three days before the date of the meeting.
- 7. The annual subscription shall be payable on the 1st of September in each year. The financial year shall end on the 31st August in each year. Members joining after 28th February can join at half rate. A statement of accounts for the preceding year shall be circulated with the notice of the Annual General Meeting. Membership of the Society may confer special concessions either as to the price of admission to any dance or otherwise, such concession to be decided by the committee, in conjunction with, if necessary, any other person or organisation interested. Members have a right to participate in activities of the Society and receive such benefits and publications as the committee may from time to time decide.
